House Bill 194

Louisiana's Higher Education
Commissioner Jim Purcell and the leaders of the four higher ed managing boards have all come out in support of HB 194, which would transfer tuition authority to the managing boards.

#### Dear Johnette,

The 2013 Louisiana Legislative Session has begun, and despite all of the discussion about the proposed tax swap, the needs of higher education are garnering attention from key legislators. Louisiana House Speaker Chuck Kleckley (R-Lake Charles) is among those supporting tuition autonomy for Louisiana colleges. His bill, House Bill 194, has been endorsed by the leaders of the higher education boards.

Southeastern Louisiana University is asking the NCAA to accept a set of self-imposed sanctions rather than administer its own punishment for athletics violations. Southeastern is in trouble with the association for allowing 137 ineligible students to play sports since 2005.

Southern University Law School is not helping its brethren as they argue they need more funds for higher education. According to the legislative auditor, \$500,000 in undeposited and unmailed checks were recently found in the office of a Southern Law School employee who had a "key accounting position." The school's financial statement was also off by \$1.5 million for 2012. According to The Advocate, "The improperly handled checks and the accounting error were the only two negatives found in the audit."
