#### Dear Johnette,

The LSU Board of Supervisors felt the ire of Judge Janice Clark yet again last week. After months of claiming there were 35 semifinalists for the top job at LSU, the Board turned over fewer names as part of an agreement with the court. The Advocate writes the LSU attorney claimed "35 was just an approximate number and the actual total could be smaller by 10 or so."

The LSU Board of Supervisors was sued by The Advocate and The Times-Picayune months ago for allegedly violating open records laws when they refused to reveal the names of candidates in the search.

As a result of the disparity in the number of candidates reported and submitted, the LSU Board is facing more than \$140,000 in contempt of court fines, attorneys' fees, and penalties to be paid to the newspapers. Clark ordered the Board pay newspaper penalties of \$100 a day to both The Advocate and Times-Picayune "until such time as all the documents are finally and fully delivered."

The LSU Board of Supervisors is filing an appeal with the Louisiana 1st Circuit Court of Appeals.

- There's another national Top 10 ranking for LSU, but don't expect a news release bragging about it. Playboy Magazine has ranked LSU as the #7 party school in the nation. The Lafayette Advertiser, 09.26.13
- An audit of the Southern University System Foundation books reported inadequate record-keeping related to the Bayou Classic and insufficient policies in place to ensure money is spent as donors intended, but the auditors reported no misuse of funds. Foundation Executive Director Ernie Hughes said, "This was a clean audit with no major findings. I'm not overly alarmed." The Advocate, 09.26.13
- State District Judge Janice Clark has imposed more fines and fees on the LSU Board of Supervisors as part of the lawsuit over their refusal to release the names of those considered for LSU President last spring. The Advocate, 09.27.13
- LSU Professor and political writer Bob Mann argues LSU fines should not be paid from taxpayer dollars or foundation funds; he believes they should be paid by the individual members of the Supervisors out of personal funds. Mann writes, "I have no doubt that more than 90 percent of the public would object to any taxpayer funds being used to pay fines assessed for the board's illegal actions." NOLA.com, 09.26.13
