Dear Johnette,

As more high-skilled, high-wage jobs move to Louisiana, the pressure is on higher education institutions around the state to produce graduates ready to fill them. We are still far from having enough skilled workers, but graduation statistics released this week show we are at least headed in the right direction.

LSU in Baton Rouge, the University of Louisiana-Lafayette, and Bossier Parish Community College all graduated their largest classes in history. At LSU, their entire 2014 class also had 10% more Hispanics, 10% more African Americans, and 3.5% more females than the previous year.

Among the BPCC graduates were 13 engineering majors, the first engineering cohort to graduate from the community college. These students are all eligible to transfer as juniors to Louisiana Tech or ULL. *For more on the BPCC graduates click here.*
